DECIDES:

Article 1: (1) A competitive entrance examination for the admission of **three hundred (300)** students into the **first year of the engineering training programme** at the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, has been launched for the **2022/2023** academic year in the following centres: **Bafoussam, Bamenda, Belabo, Bertoua, Buea, Douala, Ebolowa, Garoua, Maroua, Ngaoundéré et Yaoundé**.

(2) The fields of study and number of available places for the competitive entrance examination are as follows:

Article 2: (1) candidates must not be more than 29 years old as of January 1, st 2022.

Article 3 : If successful in the competitive entrance examination, candidates awaiting the results of the aforementioned official examination shall be admitted into the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, only upon presentation of an testimonial of success or the results slip of the certificate obtained in 2022, and before the deadline set by the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua at Belabo.

Article 4 : The application file shall comprise the following:

- a- An online individual record form duly filled by the candidate on the entrance examination page of the school's website: <http://www.isabeeb.cm>;
- b- A photocopy of the National Identity Card;
- c- A certified true copy of the birth certificate (not more than 3 months old);
- d- Certified photocopies of the Probatoire or the GCE O/L and the Baccalaureat or the GCE A/L transcripts;
- e- Certified photocopy of the Baccalaureat or the GCE A/L, or any certificate recognized as equivalent to them by the Minister of State, Minister of Higher Education, which must not be more than three (03) months old from the date of issue, or a certified photocopy of results slips of the Baccalaureat or the GCE:AL;
- f- A medical certificate of physical fitness issued by a state medical doctor;
- g- A self-addressed A4-size stamped (1.000 francs CFA) envelope;
- h- A receipt of twenty thousand (20 000) FCFA as examination fee.

Article 5 : The examination fee of **twenty thousand (20 000) francs CFA** shall be payed only through **EXPRESS UNION** with a receipt issued on payment. The receipt must be attached to the candidate's application file. The examination fee, which is non-refundable, shall be used to cover expenses related to the organization of the examination. **Any other means of payment shall not be accepted.**

Article 6: The complete application file shall reach either the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, or the Regional Delegation of the Ministry of Secondary Education of the candidate's place of residence, **latest the 04th of October 2022**. However, foreign candidates of countries in the CEMAC region shall deposit their files at the office of the Cameroonian diplomatic representatives of their respective countries.

Article 7: The written part of the entrance examination will take place on **06th November 2022** in the following locations of the centres:

Bafoussam (IUT-Fotso Victor de Bandjoun), Bamenda (Delegation of secondary education, Up Station), Belabo (Lycée Technique), Bertoua (Lycée Scientifique), Buea (Delegation of secondary education), Douala (Lycée de Deido), Ebolowa(ENSET), Garoua (Lycée Classique et Moderne), Maroua (Collège de l'Espoir), Ngaoundéré (Lycée Classique et Moderne) and Yaoundé (Lycée Technique Commercial de Ngoa Ekelé).

Article 8 : (1)The entrance examination shall comprise candidates' academic performance that will account for 25% of the assessment, and three written papers that will represent 75% of the assessment.

(2) Marks for the candidate's academic performance shall be determined the candidate's age and the number of years spent in secondary school.

Article 9: (1) The syllabus is that of *Première* and *Terminale* series mentioned above for candidates of the Francophone Sub-system, or for Lower and Upper Sixths of these series for candidates of the Anglophone Sub-System.

Article 10: At the end of the deliberations, the jury shall prepare the list of successful candidates following the different series and in order of merit and the final results shall be published by the Minister of State, Minister of Higher Education.

Article 11: The jury's make-up mentioned in article 10 is specified by the Minister of State, Minister of Higher Education in conformity with the rules and regulations in force.

Article 12: The Rector of the University of Bertoua, the Director of the Department of University Accreditations and Quality, and the Director of the Higher Institute of Agriculture, Wood, Water and Environment of the University of Bertoua, at Belabo, each in his own sphere, are responsible for the implementation of this decision which shall be registered and published in English and French, wherever necessary.
