HEREBY ANNOUNCES:

Article 1: A competitive entrance examination, based on file study for admission into the Special Science Classes section of the Higher Teacher Training College has been launched for the 2021/2022 academic year.

Article 2: The number of places opened for the competitive entrance examination are as follows:

- 35 students for mathematics series;
- 35 students for sciences series.

Article 3: The competitive entrance examination is opened to male and female Cameroonians aged 21 years at most by December 2020 who hold of the following certificates obtained during the 2020/2021 academic year:

- for mathematics series, the Baccalauréat scientifique in series C, D, E, or the GCE AL (Mathematics, Physics and Chemistry);
- for sciences series, the Baccalauréat in series C, D, F or the GCE AL (Biology, Physics and Chemistry).

Article 4: Complete application files shall comprise the following documents:

- A registration form available in ENS, Regional Delegations of Secondary Education, on MINESUP website http://www.minesup.gov.cm or the ENS website
 http://www.ens.cm
- A certified photocopy of the birth certificate issued not more than six (6) months ago;
- GCE O/L or probatoire certificate or attestation;
- GCE O/L or probatoire results slip;
- GCE A/L or Baccalauréat certificate or attestation;
- GCE A/L or Baccalauréat results slip;
- A medical certificate (form provided by ENS);
- A receipt of twenty thousand (20,000) CFA as registration fees issued by UBA account N° 10033-05211-11004000007-50. No other form of payment is accepted:
- An A4 self-addressed envelope bearing a stamp at the rate in force.

<u>Article 5</u>: All complete application files should be submitted at the Higher Teacher Training College (Administrative Bureau for the Special Science Classes) latest October 06th, 2021.

Article 6: The results shall be published by the Minister of State, Minister of Higher Education.

Article 7: The examination fees are non-refundable.

<u>Article 8</u>: The Rector of the University of Yaoundé I, the Director of the Department of University Accreditations and Quality, and the Director of the Higher Teacher Training College, each in his/her own sphere, is responsible for the implementation of this press release which shall be registered and published in English and French wherever necessary.
